Sec. 162.032. PENALTIES. (a) A trustee who misapplies trust funds amounting to \$500 or more in violation of this chapter commits a Class A misdemeanor. ### PROPERTY CODE CHAPTER 162. CONSTRUCTION PAYMENTS ... - Texas

As is the case in any remedial statute, courts "must" give the Construction Trust Fund Act "broad construction to effectuate its protective purposes." Unlike a mechanic's lien, provided for in Chapter 53 of the Texas Property Code and Article 16, Section 37 of the Texas Constitution, there are no procedural requirements made of a subcontractor or materialman before they qualify for protections under the Construction Trust Fund Act.
