Landlord Legal Guide - Henley Charles Estate Agents

"Landlord" means the owner, lessor, or sublessor of the dwelling unit or the building of which such dwelling unit is a part. "Landlord" also includes a managing agent of the premises who fails to disclose the name of such owner, lessor, or sublessor. Such managing agent shall be subject to the provisions of § 16.1-88.03.

Virginia Residential Landlord and Tenant Act

If you and your landlord don't come an agreement, and the rent is higher than you'd like, you can either agree to pay the new price, or reject it and move out. If you decide to move, Philadelphia law requires you to give your landlord written notice within 30 days of receiving notice of a rent increase, if the lease is for one year or longer.
